Thank you to everyone that came out and attended the open meeting. We appreciate all the support from the community. We discussed many things at the meeting one of which is that the board recently voted to decrease the number of board seats from 9 to 7. The HOA is currently accepting applications for the 2017-2018 term. Four of the current board members are re-running but we still need more volunteers. Please consider putting your name into the mix and supporting your community and helping make a difference.

We hope to see you all at the annual meeting on Thursday October 26th at 7:00pm at KES. Over the next week, you will be receiving a letter with further information about the meeting, along with two very important documents. The first one is the proxy for the annual meeting. Please return the proxy even if you are planning on attending the meeting, so that just in case you can't make it, the proxy is there to help make quorum. When you arrive at the meeting, your proxy will be returned to you with your ballot. The proxy will allow a person who you designate the ability to vote on your behalf. If you do not designate someone, proxy will fall to the board president. We will be voting on the new Board of Directors and several changes to the HOA by-laws. The second document you will receive is a ballot to change the covenants. In order for the changes to the covenants to be made, we must have 75% of the homeowners vote on each proposed change. Please complete the ballot and return as soon as possible.

The BOD is doing the absolute best that we can for the community and sometimes things don't move as fast as we would like them but we have been happy with our progress this year and hope that everything continues to improve. Witches Brew

A spooky cocktail that can be made for all ages

Ingredients:

2 cups orange juice

½ cup lemon juice

1 750ml bottle sparkling apple cider (or 4 cups apple cider)

1 750ml bottle sparkling white grape juice (or sparkling wine)

Dry ice (can be found in the frozen food section at the grocery store)

Combine the orange and lemon juices in a large pitcher or punch bowl. Add cider then sparkling grape juice or sparkling wine.

Slowly add dry ice to bowl but make sure the liquid is not all the way to the top so it doesn't spill out. Reserve small chunks for adult individual cups. This can be very strong and can easily be diluted with club soda. Enjoy immediately. Makes about 11 cups.
